11 Rhoda Goldman Plaza as part of its continuum of care for seniors and their families; and,

12 WHEREAS, The Rhoda Goldman Plaza is a 155-unit complex with services to fulfill the  
13 social, wellness, religious, and educational needs of its residents; and,

14 WHEREAS, The Rhoda Goldman Plaza has been designed to embrace a holistic  
15 approach to living while offering a continuum of care and resources to nurture independent  
16 living; and,

17 WHEREAS, The new Jewish Family and Children's Services headquarters will also be  
18 located at the Rhoda Goldman Plaza in the Miriam Schultz Grunfeld Professional Building;  
19 and,

20 WHEREAS, The Rhoda Goldman Plaza will be the City's only assisted living  
21 community built under Jewish auspices; now, therefore, be it

22 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
23 celebrates the opening of the Rhoda Goldman Plaza; and, be it

24 FURTHER RESOLVED, That the Board declares August 1, 2000 "Rhoda Goldman  
25 Plaza Day" in the City and County of San Francisco.


