ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

RESOLVED, That, in accordance with the provisions of the California Vehicle Code and the San Francisco Traffic Code, the following regulations governing the movement of vehicles are hereby enacted or rescinded as designated below:

BICYCLE LANES - ESTABLISH

Turk Street, both sides (eastbound and westbound), between Arguello Boulevard and Baker Street

LEFT LANE MUST TURN LEFT - ESTABLISH

Haight Street, westbound, at Octavia Street

ONE-WAY STREET - RESCIND

Haight Street, westbound, between Octavia and Laguna Streets (restores two-way operation)

TOW-AWAY, NO STOPPING, 3 PM - 6:30 PM, MONDAY THROUGH FRIDAY - RESCIND
TOW-AWAY, NO STOPPING, 3 PM - 7 PM, MONDAY THROUGH FRIDAY - ESTABLISH

Pine Street, north side, between Davis and Front Streets (change in hours of operation only)

TOW-AWAY, NO STOPPING, 7 AM - 9 AM AND 3 PM - 6:30 PM, MONDAY THROUGH FRIDAY - RESCIND

TOW-AWAY, NO STOPPING, 7 AM - 9 AM AND 3 PM - 7 PM, MONDAY THROUGH FRIDAY - ESTABLISH




