2 AUTHORIZING THE AIRPORT COMMISSION TO ACCEPT AND EXPEND A GRANT IN
3 THE AMOUNT OF \$140,000 FROM THE BAY AREA AIR QUALITY MANAGEMENT
4 DISTRICT (AIR DISTRICT) FOR ACQUISITION OF COMPRESSED NATURAL GAS
5 (CNG) BUSES

7 WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks
8 to reduce vehicle emissions in the region and on terminal roadways;
9 and,

11 WHEREAS, The Air District assists public agencies in
12 implementing emissions reduction projects, such as the addition of
13 CNG vehicles to fleets; and,

15 WHEREAS, The Airport Commission in Resolution 00-0188, approved
16 seeking, accepting, and expending Air District funds for natural gas
17 vehicles in 2000; and,

19 WHEREAS, The Airport would administer this grant, disburse
20 incentive funds to contract operator SFO Shuttle Bus in partial
21 payment of vehicle acquisition costs, and provide the Air District
22 with information concerning the new vehicles; and

24 WHEREAS, No Airport funds would be used for this program; and

25

26 WHEREAS, This demonstration project would continue the Airport's
27 reputation as a regional leader in promoting clean fuel use among
28 ground transportation providers; and

3 grant budget; now, therefore, be it


4 RESOLVED, That, pursuant to San Francisco Administrative Code


