AUTHORIZING THE AIRPORT COMMISSION TO ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF \$140,000 FROM THE BAY AREA AIR QUALITY MANAGEMENT DISTRICT (AIR DISTRICT) FOR ACQUISITION OF COMPRESSED NATURAL GAS (CNG) BUSES

WHEREAS, No Airport funds would be used for this program; and WHEREAS, This demonstration project would continue the Airport's reputation as a regional leader in promoting clean fuel use among

ground transportation providers; and

WHEREAS, The Airport proposes to maximize use of available grant funds on program expenditures by not including indirect costs in the grant budget; now, therefore, be it

RESOLVED, That, pursuant to San Francisco Administrative Code §10.171, the Board of Supervisors does hereby authorize the Airport Commission to accept and expend funds awarded in this grant; and be it

FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in the grant budget; and be it

FURTHER RESOLVED, That although the City has incurred no legal obligation, the Board of Supervisors does hereby ratify the action previously taken.
