

1 [Accept-Expend Special District Grant]  
2 AUTHORIZING THE AIRPORT COMMISSION TO ACCEPT AND EXPEND A GRANT IN  
3 THE AMOUNT OF \$980,000 FROM THE BAY AREA AIR QUALITY MANAGEMENT  
4 DISTRICT (AIR DISTRICT) FOR ACQUISITION OF COMPRESSED NATURAL GAS  
5 (CNG) SHUTTLE VEHICLES

7 WHEREAS, Pursuant to its Clean Vehicle Policy, the Airport seeks  
8 to reduce vehicle emissions in the region and on terminal roadways;  
9 and,

10 WHEREAS, The Air District assists public agencies in  
11 implementing emissions reduction projects, such as the addition of  
12 CNG vehicles to fleets; and,

13 WHEREAS, The Airport Commission in Resolution 00-0188, approved  
14 seeking, accepting, and expending Air District funds for natural gas  
15 vehicles in 2000; and,

16 WHEREAS, The Airport would administer this grant, disburse  
17 incentive funds to permitted third party passenger carriers, and  
18 provide the Air District with information concerning the new  
19 vehicles; and

20 WHEREAS, No Airport funds would be used for this program, and  
21 the Airport would have no ownership interest in third party CNG  
22 vehicles; and

23 WHEREAS, This demonstration project would continue the Airport's  
24 reputation as a regional leader in promoting clean fuel use among  
25 ground transportation providers; and

1 WHEREAS, The Airport proposes to maximize use of available grant  
2 funds on program expenditures by not including indirect costs in the  
3 grant budget; now, therefore, be it

4 RESOLVED, That, pursuant to San Francisco Administrative Code  
5 §10.171, the Board of Supervisors does hereby authorize the Airport  
6 Commission to accept and expend funds awarded in this grant; and be  
7 it

8 FURTHER RESOLVED, That the Board of Supervisors hereby waives  
9 inclusion of indirect costs in the grant budget; and be it

10 FURTHER RESOLVED, That although the City has incurred no legal  
11 obligation, the Board of Supervisors does hereby ratify the action  
12 previously taken.




