URGING THE DISTRICT ATTORNEY AND THE SAN FRANCISCO POLICE DEPARTMENT TO EXPEDITE A FULL INVESTIGATION OF THE DEATH OF CHRISTOPHER ROBERTSON.

WHEREAS, On the night November 17, 2000 while riding home on bicycles with friends, Chris Robertson was struck and killed by 18-wheeler big rig on Fourth and Brannan Streets; and

WHEREAS, The driver has been identified as Rueben Espinosa and is currently in custody by law enforcement officials but has not been charged; and

WHEREAS, Chris Robertson's friends who witnessed the incident as well as others have alleged that Rueben Espinosa willfully ran over Chris in fit of rage ; and

WHEREAS, Chris Robertson was long time member of the Bicycle Coalition and a community activist; and

WHEREAS, Chris was regarded by friends and colleagues as a very competent cyclist as well as a responsible bicyclist would never taunt drivers or do other types of irresponsible and dangerous acts ; and

WHEREAS, It is the policy of the City and County of San Francisco to promote alternative uses of transportation in order to mitigate traffic congestion as well as environmental problems; and

WHEREAS, It is also the policy of the City and County of San Francisco to abhor any actions on the part of individuals or groups that willfully and maliciously cause injury and violence to its citizens and that the perpetrators of such willful acts of violence will be fully investigated and prosecuted to full extent of the law; now therefore be it
