FURTHER RESOLVED, That this Board of Supervisors hereby finds and determines that there is no substantial evidence that the Jobs-Housing Linkage Ordinance will have a significant effect on the environment and that the negative declaration reflects the lead agency's independent judgment and analysis; and be it

FURTHER RESOLVED, That this Board of Supervisors adopts and incorporates herein by reference thereto the findings of the final negative declaration, [Case #1999.178E], issued by the Planning Department, a copy of which is on file with the Clerk of the Board of Supervisors.
