WHEREAS, St. Mary's Medical Center, an affiliate of Catholic Healthcare West, operates the Adult Psychiatric Partial Hospitalization and AfterCare Intensive Outpatient programs, which are currently at high risk for closure; and

WHEREAS, This two-track program provides much needed services to very particular patient populations, including the only the only Geriatric Psychiatry Partial Hospitalization Program in the City; and

WHEREAS, The program is specifically designed to minimize repeated hospitalizations for the at-risk psychiatric patient population, often serving to keep patients out of residential treatment or higher levels of care; and

WHEREAS, The other comparable program in the City is the "Bridge to Wellness" (affiliated with UCSF and RAMS) is filled to capacity and as such cannot accommodate St. Mary's patients; now, therefore, be it

RESOLVED, That the Board of Supervisors of the City and County of San Francisco hereby urges Catholic Healthcare West and the administration of St. Mary's Medical Center to take all steps necessary to maintain the Adult Psychiatric Partial Hospitalization and AfterCare Intensive Outpatient programs, including, if necessary, moving the programs to another location within St. Mary's Medical Center or Saint Francis Memorial Hospital; and be it

FURTHER RESOLVED, That the Board of Supervisors urges the Director of Public Health to investigate and report back to the Board of Supervisors whether a proposed closure of such programs would be subject to hearings of the San Francisco Health Commission pursuant to Proposition Q.
