[Contract with California Youth Authority for Emergency Services for Juvenile Wards of the Court]

Resolution authorizing the Chief Probation officer of the Juvenile Probation Department to renew a contract with the California Youth Authority for emergency custody of juvenile wards of the Court from the County of San Francisco.

WHEREAS, From time to time, the Juvenile Court may determine that emergency custody of a minor is required as can be provided at a Youth Authority facility; and,

WHEREAS, After the Juvenile Court has determined that a juvenile ward of the Court is eligible for emergency custody in the Youth Authority; and,

WHEREAS, The California Youth Authority has agreed to provide emergency custody of a Juvenile ward of the Court; and,

WHEREAS, The term of this contract shall be from July 1, 2000 to June 30, 2001; and,

WHEREAS, The County agrees to reimburse CYA an amount not to exceed \$2580 per month or \$10,000 for the fiscal period above, which shall be paid for from the Probation Services Division Maintenance of
