3 **Resolution authorizing the District Attorney of the City and County of San Francisco to**
4 **retroactively apply for, accept and expend funds made available through The Office of**
5 **Criminal Justice Planning for a project entitled “Violence Against Women Vertical**
6 **Prosecution” and waiving indirect costs due to funding constraints.**

8 WHEREAS, The City and County of San Francisco desires to continue a certain
9 project designated the Violence Against Women Vertical Prosecution to be funded in part
10 from funds made available through the Violence Against Women Act (“VAWA”), administered
11 by the California Office of Criminal Justice Planning (“OCJP”); and,

12 WHEREAS, this project will investigate and vertically prosecute cases of violence,
13 domestic violence, and sexual assault against elderly women and other particularly vulnerable
14 victims; now, therefore, be it

15 RESOLVED, That the District Attorney of the City and County of San Francisco is
16 authorized, retroactively, on behalf of the City and County of San Francisco to accept and
17 expend continued funding for this project from OCJP, and waiving indirect costs due to
18 funding constraints; and, be it

19 FURTHER RESOLVED, That the District Attorney is authorized, retroactively, to
20 execute on behalf of the City and County of San Francisco the necessary Grant Award
21 Agreements for this project including any extensions, funding augmentations from OCJP, or
22 amendments thereof; and, be it

23 FURTHER RESOLVED, That the applicant agrees to provide all in-kind or cash match
24 contributions required for said project (including any amendments thereof) under the program
25 and funding terms and conditions of OCJP; and be it

1 FURTHER RESOLVED, That any liability arising out of the performance of the Grant
2 Award Agreement, including civil court actions for damages, shall be the responsibility of the
3 grant recipient and the authorizing agency. The State of California and OCJP disclaim
4 responsibility for any such liability; and be it

5 FURTHER RESOLVED, That grant funds received hereunder shall not be used to
6 supplant expenditures controlled by this body.




