WHEREAS, On June 26, 2000, the Board of Supervisors initiated the process to amend the Municipal Code, Part II, Chapter II (Planning Code), when the Honorable Mark Leno introduced two proposed ordinances to create a Glen Park Special Use Subdistrict with commercial use size limitations, and to amend the Zoning Map to reflect the new Glen Park Special Use Subdistrict, copies of which are on file with the Clerk of the Board of Supervisors in File No. 001208 and File No. 001209, respectively; and,

WHEREAS, On July 5, 2000, the proposed ordinances were referred to the Planning Commission, which currently is reviewing the proposed ordinances; and,

WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by resolution, extend the prescribed time within which the Planning Commission is to render its decision on proposed amendments to the Planning Code initiated by the Board of Supervisors; and,

WHEREAS, on October 10, 2000, in Resolution 891-00, the Board of Supervisors extended the period within which the Planning Commission was to render its decision on the proposed amendments for an additional 90 days, or until January 1, 2001; and

WHEREAS, on February 2, 2001, in Resolution 59-01, the Board of Supervisors extended the period within which the Planning Commission was to render its decision on the proposed amendments for an additional 90 days, or until April 11, 2001; and

WHEREAS, The Planning Department has requested additional time to review the proposed ordinances; and,

SUPERVISOR LENO BOARD OF SUPERVISORS WHEREAS, The Board deems it appropriate in this instance to grant to the Planning Commission additional time to review the proposed ordinances and render its decision; now, therefore, be it

RESOLVED, That by this resolution, the Board hereby extends the prescribed time within which the Planning Commission may render its decision on the proposed ordinances to create a Glen Park Special Use Subdistrict and to amend the Zoning Map to reflect the new Glen Park Special Use Subdistrict, copies of which are on file with the Clerk of the Board of Supervisors in File No. 001208 and File No. 001209, respectively, for an additional 6 months, or until October 12, 2001.
