3 **Resolution urging the San Francisco Department of Parking and Traffic to continue its**
4 **efforts to improve pedestrian safety along Phelan Avenue by continuing to work with**
5 **Archbishop Riordan High School and City College of San Francisco on further**
6 **pedestrian safety improvements.**

8 WHEREAS, Pedestrian and bicyclist safety has become a growing problem in the City
9 and County of San Francisco as evidenced by an increased number of pedestrian and
10 bicyclist injuries and deaths in the past few years; and

11 WHEREAS, The Department of Parking and Traffic is aware of this increasing problem
12 and has taken some steps to make the streets of San Francisco safer for both pedestrians
13 and bicyclists; and

14 WHEREAS, Thousands of students from Archbishop Riordan High School and the City
15 College of San Francisco cross Phelan Avenue everyday; and

16 WHEREAS, Approximately three Archbishop Riordan High School students are hit by
17 automobiles annually; and

18 WHEREAS, Automobiles driving through the Phelan Avenue and Judson Street
19 intersection often speed through the intersection leaving the drivers blind to pedestrians
20 crossing the street; and

21 WHEREAS, The Department of Parking and Traffic has been working with both
22 Archbishop Riordan High School and City College of San Francisco to improve pedestrian
23 safety along Phelan Avenue; and

24 WHEREAS, The San Francisco Youth Commission will be addressing this issue at
25 their next Commission meeting; now, therefore, be it

RESOLVED, That the Board of Supervisors urges the San Francisco Department of Parking and Traffic to continue its efforts to improve pedestrian safety along Phelan Avenue by continuing to work with Archbishop Riordan High School and City College of San Francisco on further pedestrian safety improvements.




