1 [Federal Funding – HOME Program.]

3 **Resolution authorizing the Mayor of the City and County of San Francisco to accept**
4 **and expend a grant from the U.S. Department of Housing and Urban Development for a**
5 **total amount not to exceed \$7,896,000 for the HOME Program authorized under Title II of**
6 **the National Affordable Housing Act of 1990, Public Law Number 101-625, and**
7 **approving the HOME Program description as described in the 2001 action plan for San**
8 **Francisco's Consolidated Plan. Indirect costs associated with the acceptance of these**
9 **grant funds will be paid by Community Development Block Grant funds; placing**
10 **\$30,000 on reserve.**

14 WHEREAS, The City and County of San Francisco is an eligible city for purposes of
15 receiving funds from the HOME Investment Partnership (HOME) Program, and has received a
16 formula allocation of Seven Million Eight-Hundred Ninety-Six Thousand (\$7,896,000); and

17 WHEREAS, The HOME Program will be used to provide funds for the development,
18 acquisition and rehabilitation of low-income housing, in accordance with the Consolidated
19 Plan Action Plan to be submitted to HUD on or before May 15, 2001; and

21 WHEREAS, The Mayor's Office of Housing has prepared a description of the proposed
22 use of HOME funds to carry out the goals of the City's Consolidated Plan Action Plan and the
23 Residence Element of the General Plan, and has incorporated that description into the Action
24 Plan; and

1 WHEREAS, A portion of the administrative and direct costs of administering the HOME
2 program are to be paid from the 2001 allocation; and

3 WHEREAS, The remainder of the administrative and direct costs of administering the
4 HOME program is an eligible Community Development Block Grant (CDBG) expense, and will
5 be paid from CDBG funds through the 2001 Community Development Program; now,
6 therefore, be it

8 RESOLVED, That the Mayor of the City and County of San Francisco is authorized to
9 accept and expend the HOME Program from the Department of Housing and Urban
10 Development according to the Federal Rules and Regulations for the program and the
11 Consolidated Plan Action Plan; and, be it

12 FURTHER RESOLVED, That the Board of Supervisors hereby approve the proposed
13 Program Description as incorporated into the Consolidated Plan Action Plan, on file with the
14 Clerk of the Board of Supervisors and incorporated herein by reference; and, be it

15 FURTHER RESOLVED, That the Mayor is hereby authorized to submit documentation
16 and certification required by the U.S. Department of Housing and Urban Development; and,
17 be it

19 FURTHER RESOLVED, That funds in the amount of \$30,000 for the Management
20 Information System are hereby placed on reserve, pending submission of budget details, to
21 be released by the Finance Committee.




