3 **Resolution approving the FY 2001-2002 update to the 2000-2002 Children's Services**  
4 **Plan for the San Francisco Children's Fund in Accordance with Charter Section 16.108.**

6 WHEREAS, In November 1991, the voters of San Francisco enacted a charter  
7 amendment which established the San Francisco's Children's Fund; and,

8 WHEREAS, The provision of this section requires that the City revenues set aside for  
9 the Fund must be used exclusively to provide services to children, less than 18 years of age,  
10 above and beyond services funded prior to the adoption of the amendment; and,

11 WHEREAS, This section further requires the Juvenile Probation Commission,  
12 Commission on the Status of Women, Human Services Commission, Youth Commission  
13 Health Commission, Public Library Commission, and Recreation and Parks Commission to  
14 hold public hearings on the Plan and those hearings were held January 18, January 24,  
15 January 25, February 5, February 6, February 6, February 18 respectively; and,

16 WHEREAS, The Board of Supervisors provides important oversight for the Children's  
17 Fund, and is acutely aware that accountability to the public is of critical importance in a fund  
18 that was created by voters; and,

19 WHEREAS, In accordance with Charter Section 16.108 the Mayor has submitted an  
20 update to the 2000-2002 Children's Services that was adopted on January 18, 2000; now,  
21 therefore, be it




