Resolution readopting the San Francisco Bicycle Plan.

WHEREAS, Section 2377 of Chapter 3 of The California Bikeways Act of the California Streets and Highways Code provides for the preparation of a bikeways plan by a city or county and submission of this plan to the California Department of Transportation for review and approval; and

WHEREAS, Section 2378 of Chapter 3 of The California Bikeways Act of the California Streets and Highways Code provides that any city or county which has received approval from the California Department of Transportation for its bikeways plan may apply to the Department of Transportation for funds for bikeways and related facilities which will implement such plans; and

WHEREAS, Section 2377 of Chapter 3 of The California Bikeways Act of the California Streets and Highways Code provides for the preparation of a bikeways plan by a city or county and submission of this plan to the California Department of Transportation for review and approval; and

WHEREAS, The Parking and Traffic Commission unanimously approved Resolution 103-97-PTC "Adopting of the San Francisco Bicycle Plan" at its January 7, 1997 meeting; and

WHEREAS, The Board of Supervisors unanimously approved Resolution 225-97 (file number 190-97-2) "Adopting of the San Francisco Bicycle Plan" at its March 10, 1997 meeting; and

WHEREAS, The "San Francisco Bicycle Plan" is on file with the Clerk of the Board of Supervisors in File No. <u>010726</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, The Parking and Traffic Commission unanimously approved Resolution 140-01-PTC "Readopting the San Francisco Bicycle Plan" at its April 17, 2001 meeting; and

WHEREAS, The Goals and Objectives of the 1997 San Francisco Bicycle Plan, as stated on page 1-2 and 1-3 of the Plan, remain current; and

WHEREAS, In order to be eligible to apply for competitive grants totaling up to \$1.8 million in FY 2001/02 state Bicycle Transportation Account funds, local agencies' governing boards must adopt a bicycle plan on July 1, 1997 or later or certify that an existing plan has been updated; and

WHEREAS, Addendum 1, listing major projects recommended in the San Francisco Bicycle Plan that have been completed or currently being implemented, has been added to the Plan and is on file with the Clerk of the Board of Supervisors in File No. 010726, which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, Addendum 2, listing new potential bicycle facility projects, in priority order, that are added to the San Francisco Bicycle Plan, has been added to the Plan and is on file with the Clerk of the Board of Supervisors in File No. 010726, which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, Addendum 3, listing updated San Francisco Bicycle Plan elements as required in Section 891.2 of the California Streets and Highways Code, has been added to the Plan and is on file with the Clerk of the Board of Supervisors in File No. 010726, which is hereby declared to be a part of this resolution as if set forth fully herein; and

WHEREAS, The updated San Francisco Bicycle Plan and the three aforementioned addenda comply with Section 891.2 of the California Streets and Highways Code and the Regional Transportation Plan; now, therefore, be it

RESOLVED, That the Board of Supervisors readopts the San Francisco Bicycle Plan, including the three new addenda referenced above; and, be it

FURTHER RESOLVED, That a copy of this resolution be forwarded to the Metropolitan Transportation Commission in conjunction with their review and certification of the San Francisco Bicycle Plan; and, be it

FURTHER RESOLVED, That a copy of this resolution be forwarded to the California Department of Transportation Bicycle Facilities Unit in conjunction with their review and approval of the San Francisco Bicycle Plan.
