3 Resolution authorizing the lease of real property at 3120 Mission Street for the
4 Department of Human Services.

6 WHEREAS, The term of the lease shall be for seven (7) years commencing upon
7 approval of the transaction by the Board of Supervisors and Mayor. If funds are not
8 appropriated in any subsequent fiscal year, City may terminate the lease upon reasonable
9 notice to Landlord. The base monthly rent shall be \$77,700 (\$2.10/s.f.) including janitorial
10 and ten parking spaces and is subject to annual CPI adjustments of no less than 3% with a
11 ceiling of 6%. At no cost to City, Landlord shall provide improvements to the base building
12 to meet remaining Title 24, ADA requirements and miscellaneous repairs; and

14 WHEREAS, City, on behalf of the Department of Human Services, shall sublease
15 a portion of the premises of ~~no less than 7,650 s.f.~~ to other public agencies, community
16 based organizations and invited partners who collaborate with the Department of Human
17 Services to provide services at the Career Link One Stop Center at a proposed rate of
18 ~~that shall increase annually in accordance with CPI adjustments to the City's base rent.~~
19 \$2.25 per square foot/~~to offset costs and the common use of space.~~ City shall hold

20 Landlord harmless from any claims or liability for any injury or damage to any person or
21 property occurring in or about the leased premises resulting from the negligence of City,
22 its agents or employees, and,


23 WHEREAS, Said lease shall be subject to certification by the Controller pursuant
24 to Section 3.105 of the Charter. The City Attorney shall approve the form of the lease;
25 now, therefore, be it




FURTHER RESOLVED, That all actions heretofore taken by the officers of the City with respect to such lease are hereby approved, confirmed and ratified.
