8 **WHEREAS;** Pursuant to Section 17.14 of the San Francisco Administrative Code, the
9 Parking and Traffic Commission and the Parking Authority Commission are responsible for
10 conducting periodical reviews of parking rates for City owned parking garages and are
11 authorized to establish trial parking rates; and,

12 **WHEREAS,** This responsibility includes annually reviewing the parking rates charged
13 at City owned garages and lots and making recommendations to the San Francisco Board of
14 Supervisors for changes in those parking rates; and,

15 **WHEREAS,** The Parking and Traffic Commission and the Parking Authority
16 Commission have reviewed the Exhibits showing the original parking rates, trial parking rates
17 and proposed permanent parking rates. On File with the Clerk of the Board of Supervisors in
18 File No. 010868, which is hereby declared to be a part of this motion as is set forth
19 full herein; now, therefore, be it

20 **RESOLVED,** That upon completion of its review, the Parking and Traffic Commission
21 and the Parking Authority Commission urge the Board of Supervisors to adopt the trial parking
22 rates as permanent parking rates with its adjustments; and, be it,


