1 [Private grant funds to the Department of Public Health from The California
2 Endowment.]

3 Resolution authorizing the San Francisco Department of Public Health,
4 Population Health and Prevention and Community Health Network, to accept and retroactively
5 expend a grant in the amount of \$399,386 from The California Endowment for the
6 period of February 15, 2001 to February 14, 2004, and to enter into an agreement
7 for the use of these funds.

8 WHEREAS, The Department of Public Health (SFDPH) has applied for and been
9 awarded a three year grant from The California Endowment in the amount of \$399,386
10 for integrated behavioral and physical health care in community-based public health
11 clinics; and,

13 WHEREAS, As a condition of receiving the grant funds, The California
14 Endowment requires the City to enter into an agreement (the "Agreement"), a copy of
15 which is on file with the Clerk of the Board of Supervisors in File No. 010917, which
16 is hereby declared to be a part of this resolution as if set forth fully herein; and,

18 WHEREAS, The award amount, term, and budget detail for each of the three
19 years of the project are incorporated into the agreement; and,

21 WHEREAS, The grant terms prohibit including indirect costs in the grant budget;
22 now, therefore, be it

23 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect
24 costs in the grant budget; and, be it

the agreement on behalf of the City; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the position
created under the grant as a "G" or grant-funded position, which would terminate when
the grant expires.


