Resolution urging the Marin Community Foundation to develop a common plan that addresses the needs of the poor in the Bay Area.

WHEREAS, the well being of the poor of the Bay Area represents an increasing responsibility and challenge to both government and philanthropic foundations; and,

WHEREAS, there is both a scarcity of philanthropic and government dollars available to serve the poor in the Bay Area; and,

WHEREAS, the largest community foundation in the Bay Area, The Marin Community Foundation, restricts its grants exclusively to those residing in Marin, whether poor or affluent; and,

WHEREAS, the Marin Community Foundation, with assets of over 1.1 billion dollars, is likely to award grants exceeding 700 million dollars over the next decade; and,

WHEREAS, many San Francisco-based non-profits provide needed services to the poor in Marin and are available to provide experienced high quality services to the poor, and in particular, new immigrant and minority groups in Marin; now, therefore, be it

RESOLVED, That the President of the Marin Community Foundation consider developing in conjunction with major San Francisco foundations, and other Bay Area foundations, a common regional plan to effectively address the needs of the poor of the Bay Area and submit such plan within 90 days to the chief administrative officers of all Bay Area counties; and, be it

FURTHER RESOLVED, That the California Attorney General, pursuant to his charitable trust jurisdiction, examine A) whether the Marin Community Foundation fully and effectively serves the needs of the poor in Marin, particularly new immigrants and minorities;
