11 700 people living with HIV/AIDS; and,

12 WHEREAS, TARC annually serves over 50,000 people to help
13 lower their risk for HIV infection; and,

14 WHEREAS, TARC is celebrating its 11 year anniversary on
15 Thursday, October 4, 2001, and is honoring Catherine Lyons, the
16 HIV Prevention Project, Catholic Healthcare West and Glenda
17 Hope; and,

18 WHEREAS, TARC works closely with the HIV Prevention Project
19 to provide information and treatment to IV drug users who are at
20 high risk for HIV; and,

21 WHEREAS, Catholic Healthcare West recently supplied a
22 \$50,000 grant this year to help fund outreach and treatment
23 programs at the Tom Waddel Health Center; and,
