3 **Resolution authorizing the Department of Human Services to retroactively accept and**
4 **expend a grant in the amount of \$9,753,765 from the U.S. Department of Housing and**
5 **Urban Development for Stewart B. McKinney Supportive Housing Program.**

7 WHEREAS, Under the Stewart B. McKinney Homeless Assistance Act as amended,
8 San Francisco is eligible to receive funds under the Supportive Housing Program (SHP) from
9 the U.S. Department of Housing and Urban Development; and,

10 WHEREAS, The U.S. Department of Housing and Urban Development has announced
11 the awarding of sixteen SHP grants to the City and County of San Francisco totaling
12 \$9,753,765 to fund programs to reduce homelessness in San Francisco; and,

13 WHEREAS, The Department of Human Services is the authorized administrator of the
14 SHP grants and has prepared an Expenditure Schedule for use of the SHP grants; and
15 \$200,660 be allocated for use as indicated on the Department of Human Services
16 Expenditure Schedule; and,

17 WHEREAS, The grant terms prohibit including indirect costs in the grant budget; now,
18 therefore, be it

19 RESOLVED, That Department of Human Services is hereby authorized to retroactively
20 accept and expend a grant of \$9,753,765 from the U.S. Department of Housing and urban
21 Development under the Supportive Housing Program; and be it

22 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
23 indirect costs in the grant budget.


