**WHEREAS**, On February 20, 2001, the Parking and Traffic Commission adopted Resolution No. 113-01-PTC authorizing the Director of Property to advertise the Invitation for Bids for the management of the North Beach Garage and the Vallejo Street Garage; and,

**WHEREAS**, Eleven (11) parking firms submitted pre-qualification questionnaires and nine (9) firms were qualified to submit bids. On file with the Clerk of the Board of Supervisors in File No. 011389, which is hereby declared to be a part of this resolution as if set forth fully herein; and,

**WHEREAS**, Pacific Park Management Incorporated submitted the lowest responsive and responsible bid, after the Human Rights Commission ratings discounts were applied, for the management of the North Beach Garage and the Vallejo Street Garage to Pacific Park Management Incorporated; now, therefore, be it

**WHEREAS**, The Parking and Traffic Commission at its meeting of July 17, 2001 passed Resolution No. 155-01-PTC, urging the Board of Supervisors to Award the Management Agreement for the North Beach Garage and the Vallejo Street Garage to Pacific Park Management Incorporated; and,

**RESOLVED**, That the Board of Supervisors approves the award of the Management Agreement for the North Beach Garage and the Vallejo Street Garage to Pacific Park Management Incorporated; and, be it

2 Management Agreement as in substantial form as approved by the City Attorney; with such
