

1 [Loan of up to fifty (50) standard Neoplan New Flyer buses to the Salt Lake Organizing
2 Committee for the Olympic Winter Games of 2002.]

3 **Resolution approving an agreement between the Salt Lake Organizing Committee for**
4 **the Olympic Games of 2002, Inc. and the City and County of San Francisco, acting by**
5 **and through its Municipal Transportation Agency, lending up to fifty (50) of City's**
6 **standard Neoplan New Flyer buses to the Salt Lake Organizing Committee for the**
7 **Olympic Games of 2002, Inc., from no later than January 1, 2002 to no later than ~~April~~**
8 **March 1, 2002 for the 2002 Winter Olympic and ~~Paralympic~~ Games.**

10 WHEREAS, The Salt Lake Organizing Committee for the Olympic and ~~Paralympic~~
11 Winter Games of 2002, Inc. (SLOC) is responsible for developing a comprehensive plan to
12 meet the transportation needs for more than 1.5 million visitors for the 2002 Winter Olympic
13 and ~~Paralympic~~ Games; and

14 WHEREAS, The Federal Transit Administration has encouraged Muni as well as other
15 transit properties throughout the United States to cooperate to the fullest extent possible with
16 the SLOC; and

17 WHEREAS, SLOC will be using a total of 900 buses from 25 different agencies for a
18 total of ~~about 3,500~~ approximately 1,300 miles of use to support the transportation needs; and

19 WHEREAS, SLOC has requested use of up to fifty (50) standard Neoplan New Flyer
20 buses to help meet the transportation needs, ~~not~~ no later than January 1, 2002; and

21 WHEREAS, Muni bus service in San Francisco would not be affected by the loan of
22 these buses to SLOC; and

1 WHEREAS, SLOC and the City have negotiated an agreement for the loan of the
2 buses to SLOC which requires the buses to be made available to SLOC no later than January
3 1, 2002 and returned to San Francisco no later than ~~April~~ March 1, 2002 (the "Agreement");
4 and

5 WHEREAS, On October 19, 2001, The Municipal Transportation Agency Board of
6 Directors adopted Resolution No. 01-105 approving the Agreement, subject to approval by
7 Board of Supervisors; and

8 WHEREAS, The Agreement is on file with the Clerk of the Board of Supervisors in File
9 No. 011999, which is hereby declared to be a part of this resolution as if set forth fully herein;
10 and,

11 WHEREAS, SLOC will agree to be fully responsible for the buses while in their
12 possession, including routine maintenance, operation and all operation and transportation
13 costs; and

14 WHEREAS, SLOC will return the buses to Muni within twenty (20) days should the
15 Director of Transportation determine that the buses are needed in San Francisco before the
16 agreed upon return date; now, therefore, be it

17 RESOLVED, That the Board of Supervisors hereby approves the Agreement between
18 the Salt Lake Organizing Committee for the Olympic Games of 2002, Inc. and the City and
19 County of San Francisco, acting by and through its Municipal Transportation Agency, lending
20 up to fifty (50) of City's standard Neoplan New Flyer buses to the Salt Lake Organizing
21 Committee for the Olympic Games of 2002, Inc., from no later than January 1, 2002 to no
22 later than ~~April~~ March 1, 2002 for the 2002 Winter Olympic and ~~Paralympic~~ Games.




