16 similar child care financing and public-private partnership models across the country; and,

17 WHEREAS, September Jarrett's policy expertise has greatly benefited the local  
18 planning council, various city departments, community-based organizations, and the City's  
19 child care field, Now Therefore Be it

20 RESOLVED, That the San Francisco Board of Supervisors presents this Certificate of  
21 Honor to Ms. September Jarrett and expresses it's gratitude for more that a decade of  
22 community Service and declare May 28<sup>th</sup> "September Jarrett Day" in the City and County of
