3 **Resolution extending the prescribed time within which the Planning Commission may**
4 **render its decision on a proposed ordinance to amend the Planning Code provisions**
5 **relating to dwelling units.**

8 WHEREAS, On December 4, 2000, the Board of Supervisors initiated the process to
9 amend the Planning Code, when Supervisor Mark Leno introduced a proposed ordinance to
10 adopt amendments to the Planning Code relating to dwelling units, a copy of which is on file
11 with the Clerk of the Board of Supervisors in File No. 002108; and,

13 WHEREAS, On December 9, 2000 the proposed ordinance was referred to the
14 Planning Commission, which currently is reviewing the proposed ordinance; and,

15 WHEREAS, The Planning Department has requested additional time to review the
16 proposed ordinance; and,

17 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by
18 resolution, extend the prescribed time within which the Planning Commission is to render its
19 decision on proposed amendments to the Planning Code initiated by the Board of
20 Supervisors; and,

22 WHEREAS, The Board previously approved file 010603 on April 9, 2001 which granted
23 an extension of 365 days for the Planning Commission to render its decision; and,

1 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning
2 Commission an additional 365 days, beginning from the end of the last 365-day extension, to
3 review the proposed ordinance and render its decision; now, therefore be it

4 RESOLVED, That The Board of Supervisors of the City and County of San Francisco
5 hereby extends the prescribed time within which the Planning Commission may render its
6 decision on the proposed ordinance to adopt amendments to the Planning Code relating to
7 dwelling units, a copy of which is on file with the Clerk of the Board of Supervisors in File No.
8 002108, for an additional 365 days.
