5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code and  
6 the San Francisco Traffic Code, the following regulations governing the parking of  
7 vehicles are hereby enacted or rescinded as designated below:

8 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

9 Noe Street between the driveways for addresses #334 and #338 (seven-foot  
10 space, accommodating two motorcycles).

11 **RESIDENTIAL PERMIT PARKING AREA "I" (1-HOUR TIME LIMIT, 9 AM - 6 PM,  
MONDAY THROUGH SATURDAY) - ESTABLISH**

12 Treat Avenue west side, between 25th and 26th Streets (1200 block), and

13 25th Street, both sides, between Folsom Street and Treat Avenue  
14 (addresses 3166 - 3199 only).

15 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM,  
MONDAY THROUGH FRIDAY) - ESTABLISH**

16 Shrader Street, both sides, between Grattan Street and Parnassus Avenue  
17 (1100 block).

18 *Categorically Exempt from Environmental Review*  
19 *Class 1(c)(9) changes in traffic and parking*  
20 *regulations where such changes do not establish*  
21 *a higher speed limit or result in more than a*  
22 *negligible increase in use of the street.*


