11 sale general alcoholic beverage control license for California Marketplace, located at  
12 Pier 39, #K-106; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and recommends approval.

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 21  
20 off-sale general alcoholic beverage control license, to Fritz Arko, Arko Designs, LLC for  
21 California Marketplace, located at Pier 39, #K-106 will serve the public convenience and  
22 necessity of the people of the City and County of San Francisco.

23 Conditions. (1) No wine shall be sold with an alcoholic content greater than 15%  
24 by volume; (2) No beer shall be sold with an alcoholic content greater than 3.2% by

1 volume; (3) Beer in containers of 16 oz. or less shall not be sold in units of less than a  
2 six-pack.
