8 Immigrant Rights Commission, pursuant to the provisions of Ordinance No. 211-97, for the

10 Vera Haile, succeeding herself, term expired, seat 1, must have a demonstrated  
11 knowledge of and interest in the health, human service, educational, or employment issues  
12 that affect immigrants residing in San Francisco for a two year term ending June 6, 2004;

13 Tamara Ribas, succeeding Richard Ow, term expired, seat 3, must have a  
14 demonstrated knowledge of and interest in the health, human service, educational, or  
15 employment issues that affect immigrants residing in San Francisco for a two year term  
16 ending June 6, 2004;

17 Hugh Wang, succeeding Vram Kouramajian, resigned, seat 7, must be an immigrant to  
18 the United States who is appointed in accordance with Section 4.101 of the Charter. In  
19 addition, members shall have a demonstrated knowledge of and interest in the health, human  
20 service, educational, or employment issues that affect immigrants residing in San Francisco  
21 for the unexpired portion of a two year term ending June 6, 2003;

22 Houston Zheng, succeeding himself, term expired, seat 9, must be an immigrant to the  
23 United States who is appointed in accordance with Section 4.101 of the Charter. In addition,  
24 members shall have a demonstrated knowledge of and interest in the health, human service,

2 year term ending June 6, 2004;
