3 **Resolution commending Juma Ventures for its recent distinction as a 2002 Promising**  
4 **and Effective Practices Network (PepNet) renewal Awardee.**

6 WHEREAS, Juma Ventures, a youth serving organization in the City and County of  
7 San Francisco, gets its name from the word Juma, which means 'work' in the widely spoken  
8 Akan language of Ghana in West Africa. Other nuances of the meaning include "gathering  
9 together" as a group or a people; and,

10 WHEREAS, Juma Ventures provides employment opportunities for Bay Area youth in  
11 social enterprises affording them a solid economic foundation from which to advance  
12 educationally, gain financial skills, and begin to build personal assets; and,

13 WHEREAS, The Juma model consists of two interwoven elements which include  
14 meaningful employment and complementary youth development services; and,

15 WHEREAS, This model empowers youth to make informed choices about the path of  
16 their future by exposing them to the variety of options available to them. Juma shows youth  
17 what they are capable of and encourages them to set and fulfill their personal and  
18 professional goals;

19 WHEREAS, Juma Ventures uses business enterprises as the vehicle to provide these  
20 opportunities to young people who have traditionally lacked access to them; and,

21 WHEREAS, Juma Ventures provides youth and young adults in the San Francisco Bay  
22 Area a clear, accessible pathway to transition out of poverty and the opportunity to envision a  
23 bold future for themselves; and,

24 WHEREAS, Promising and Effective Practices Network ("PEPNet"), a system and  
25 information base for identifying and promoting best practices in youth employment and




