5 **funds totaling \$15,000 from the Bay Area Rapid Transit (BART) for the Glen Park BART**  
6 **Station Area Plan Project in the City and County of San Francisco.**

8 WHEREAS, The San Francisco Planning Department and its partners, the San  
9 Francisco Bay Area Rapid Transit District (BART) and the San Francisco Public Library desire  
10 to undertake a community planning process to enhance community livability and to improve  
11 overall transportation circulation within the one-quarter mile radius of the Glen Park BART  
12 station; and,

13 WHEREAS, The Planning Department has applied for a Community-Based  
14 Transportation Planning Grant from the California Department of Transportation (Caltrans) to  
15 fund this undertaking; and,

16 WHEREAS, Caltrans has notified the Planning Department that the Glen Park BART  
17 Station Area Plan Project was awarded a Community-Based Transportation Planning Grant in  
18 the amount of \$80,000; and,

19 WHEREAS, Caltrans has agreed to provide funding for this planning project with its  
20 State Highway Account Community-Based Transportation Planning funds for fiscal year  
21 2001-02; and,

22 WHEREAS, The aforementioned state funds will cover eighty (80) percent of the  
23 eligible costs as administered by Caltrans; and,


24 WHEREAS, BART has agreed to provide \$15,000 of the required matching funds from  
25 its Capital Funds; and,

1 WHEREAS, The Planning Department will provide the remaining \$5,000 of required  
2 matching funds in departmental funds for the non-state share; and,


3 WHEREAS, Indirect costs are ineligible according to state rules and regulations; now,




