WHEREAS, The San Francisco Urban Service Project (“USP”) was founded in 1992 with the purpose of uniting diverse young leaders with community action in order to promote social change; and,

WHEREAS, USP’s community action involves Urban Service Corps Members working full-time and completing hundreds of hours of community service throughout the year; and,

WHEREAS, USP’s leadership development opportunities allow youths to develop professional skills related to their work, gain tools for personal development, and analyze key social issues; and,

WHEREAS, USP’s training sessions incorporate retreats, service projects, workshops, discussions, and team-building activities; and,

WHEREAS, USP’s 2001-2002 program graduated 29 Corps members who implemented over 300 youth programs, created over 600 leadership opportunities, brought over 1000 educational resources, and worked over a total of 50,000 hours with San Francisco children and youth; and,

WHEREAS, In May 2002, the USP was awarded a Certificate of Honor for “excellent service to our youth activist program” by Coleman Advocates for Children and Youth; and,

WHEREAS, Over eighty percent of all USP Corps members have continued on to careers in education, youth development, community activism, and many other social services; and,

1 WHEREAS, The work of USP is critical to ensure support for our young people by
2 giving access to resources and a well-rounded education; now, therefore, be it

3 RESOLVED, That the City and County of San Francisco Board of Supervisors does
