10 WHEREAS, Steve Chow is seeking transfer of a Type 21 off-sale general
11 alcoholic beverage control license for 7-Eleven Food Store #33006 located at 2650
12 Mason Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
20 off-sale general alcoholic beverage control license from 501 Broderick Street to 2650
21 Mason Street for Steve Chow for 7-Eleven Food Store #33006, will serve the public
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: (1) No wine shall be sold with an alcoholic content greater than 15%
24 by volume; (2) No beer shall be sold with an alcoholic content greater than 3.2% by

1 volume; (3) the petitioner shall be responsible for maintaining free of litter the area in
2 front of and adjacent to the premises over which they have control.




