10 WHEREAS, SFPDH has applied for and been awarded a grant from DOJ in the
11 amount of \$100,000 to promote mental health and reduce youth violence and substance
12 abuse in the Mission District and Bayview Hunters Point; and,

13 WHEREAS, As a condition of receiving the grant funds, DOJ requires the City to enter
14 into an agreement (the "Agreement"), a copy of which is on file with the Clerk of the Board of
15 Supervisors in File No. 021840, which is hereby declared to be a part of this
16 resolution as if set forth fully herein; and,

17 WHEREAS, The grant budget includes provision for indirect costs of \$13,793; now,
18 therefore, be it


19 RESOLVED, That SFPDH is hereby authorized to accept and expend retroactively a
20 grant in the amount of \$100,000 from DOJ; and, be it

21 FURTHER RESOLVED, That SFPDH is hereby authorized to accept and expend the
22 grant funds in accordance with the requirements set forth in the Agreement pursuant to San
23 Francisco Administrative Code section 10-170-1; and, be it

24 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
25 agreement on behalf of the City; and, be it


1 FURTHER RESOLVED, That the Controller is directed to designate the positions




