4 **Resolution authorizing the Sheriff's Department: to accept and expend a three-year**  
5 **grant in the amount of \$ 1,229,622 from the U.S Department of Education for providing**  
6 **a life skills program to women offenders.**

8 WHEREAS, The U.S. Department of Education has made available funding through  
9 the Life Skills for Prisoners Program; and,

10 WHEREAS, Due to the need to further support prisoners in developing life skills for  
11 successfully reentering the community upon release, the Sheriff's Department will provide a  
12 life skills program for women offenders; and,

13 WHEREAS, The grant identifies non-federal funds of \$988,671; and,

14 WHEREAS, The grant includes provision for indirect costs of \$9,582 for Year One;  
15 now, therefore, be it RESOLVED, That a grant award notification has been received from the  
16 U.S. Department of Education; and be it

17 FURTHER RESOLVED, That the grant provides for the creation of two positions as  
18 follows: Class 2588 – Health Worker IV at a salary of \$ 2,028 BW plus benefits; and 0.50 FTE  
19 Class 8304 Deputy Sheriff at a salary of \$ 2,554 BW plus benefits; and, be it


20 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San

22 from the U.S. Department of Education; and be it


23 FURTHER RESOLVED, That the City and County of San Francisco will adhere to all  
24 conditions specified in the grant agreement.


