6 WHEREAS, The Board of Supervisors passed Ordinance No. 14-03, File No. 021815
7 which was amended by the Board on 1/13/03, prohibiting departments from publishing hard
8 copies of annual reports without prior approval by the Board of Supervisors, and

10 WHEREAS, San Francisco City Employees' Retirement System's Annual Report
11 provides information on yearly investment activity and reviews the performance of the
12 Trust Fund assets; and

13 WHEREAS, San Francisco City Employees' Retirement System's Annual Report
14 also provides information on the San Francisco 457 Deferred Compensation Plan and
15 enumerates values of the twenty-four core investment funds; and

17 WHEREAS, The San Francisco City Employees' Retirement System serves over
18 52,000 members, with over 18,000 who are of the senior population; and

19 WHEREAS, Many senior citizens do not own a computer or are not familiar with
20 concept of downloading files, and


21 WHEREAS, The San Francisco City Employees' Retirement System requests authority
22 to print copies of its annual report necessary to be forthcoming to our clients' and to
23 disseminate information on the pension trust assets; and


