WHEREAS, The San Francisco City Employees' Retirement System proposes to spend not more than \$500.00 in reproduction costs to produce not more than 100 hard copies each year; now therefore be it

RESOLVED, That the Board of Supervisors authorized the San Francisco City Employees' Retirement System to print its Annual Report for distribution to interested parties.
