Conditions: 1) Entertainment provided shall not be audible beyond the area under control of the licensee; 2) The petitioner(s) shall police the area under their control in an effort to prevent the loitering of persons about the premises; 3) The petitioner(s) shall regularly police the alleyway (Rowland Alley) adjacent to the premises to prevent the loitering of patrons; 4) The petitioner(s) shall be responsible for

maintaining free of litter the area adjacent to the premises over which they have control; 5) Rowland Alley shall not be used for the disposal of garbage including bottles and cans nor shall it be used for the storage of garbage receptacles; 6) Sales and service of alcoholic beverages shall be restricted to 11:00 a.m. and 2:00 a.m. each day of the week.
