FURTHER RESOLVED, That, as provided under Sections 37350.5, 37351, 37352, 38010, and 40404 of the California Government Code, and Sections 1240.010 through 1240.050, inclusive, of the California Code of Civil Procedure, which authorize the City to acquire the property by eminent domain for open space, the City Attorney is hereby authorized and directed to commence proceedings in eminent domain against the owners of the Property, and any and all interests therein or claims thereto, for the condemnation thereof for the public use by the City for open space; and be it

FURTHER RESOLVED, That the cost to acquire the property by eminent domain shall ((CRPACQ/01; CRP816; CRP818; be paid from Appropriation No.REC2SOSPCPR: CRP851; CRPNPS/EPPK03), in an amount not to exceed \$ 1,825,000 (including closing costs), unless an additional certification is secured.
