Resolution retroactively approving the Public Utilities Commission's approval of the fourth year renewal of Agreement No. CS-524, Program Management Services, with the Water Infrastructure Partners (WIP) to provide program management services for the SFPUC Capital Improvement Program, for an amount not to exceed \$11 million; <u>placing contract budget authority of \$2,500,000 on reserve;</u> approving the Contract Year 3 performance fee for an amount not to exceed \$497,000; <u>requiring that the PUC report to the Finance and Audits Committee as part of the PUC's annual budget review process.</u>

WHEREAS, The terms of the contract for San Francisco Public Utilities Commission Agreement No. CS-524, Program Management Services, require an annual approval by the San Francisco Board of Supervisors; and

WHEREAS, Amendment No. 2 to the subject contract requires the PUC General Manager to request Board of Supervisors approval for any performance fee payments made to the Contractor; and

WHEREAS, The cost of services is not to exceed \$45 million over four years, and not to exceed \$11 million for Year 4 of the contract; and

WHEREAS, HRC goals of 30% MBE and 10% WBE participation were established for the first year of the contract. The goals are increased by 2% MBE and 1% WBE for each year of the contract. The HRC goals for Year 4 are established at 36% MBE and 13% WBE. These goals have been approved for this agreement by the HRC Contract Compliance Officer and committed to by the Water Infrastructure Partners; and

Public Utilities BOARD OF SUPERVISORS WHEREAS, HRC has confirmed that the Water Infrastructure Partners are in compliance with the San Francisco Administrative Code Chapter 12B, Equal Benefits requirement; now, therefore, be it

RESOLVED, That the Board hereby retroactively approves renewal of the fourth year of Agreement No. CS-524 Program Management Services, with the WIP to provide program management services for the SFPUC Capital Improvement Program, for an amount not to exceed \$11 million, and approves the Contract Year 3 performance fee for an amount not to exceed \$497,000; and, be it

 <u>FURTHER RESOLVED, That the PUC will report to the Finance and Audits</u>

 <u>Committee, as part of the PUC's annual budget review process throughout the term of the</u>

 <u>PUC's Water System Capital Improvement Program, on (a) the details of all outside</u>

 <u>contractors being used, including the scope and cost of each contract, and (b) the details of all</u>

 <u>City Staff working on the program, including their classifications, duties, and salary costs.</u>

 <u>FURTHER RESOLVED, That \$2,500,000 of Contract Year 4 funds for Project</u>

 <u>Management Contract Services are placed on reserve pending a PUC report back to the</u>

 <u>Finance and Audits Committee, by July 30, 2004, as to the status of the expended and</u>

 unexpended funds under the contract.
