WHEREAS, Airport staff and American have negotiated a modification of the Lease which reduces terminal space in Terminal 3 under the Lease with a corresponding reduction in terminal rent; and

WHEREAS, On April 7, 2004, pursuant to Resolution No. 04-0065, the Airport Commission approved Modification #9 to the Lease. A copy of the form of the Modification is on file with the Clerk of the Board of Supervisors in File No. <u>040582</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

RESOLVED, That this Board of Supervisors hereby approves and authorizes the execution of Modification #9 to Lease and Use Agreement L-82-0111 for terminal space in Terminal 3 of the Airport, between American Airlines, Inc. and the City and County of San Francisco, acting by and through its Airport Commission.
