3 **Resolution authorizing the Mayor’s Office of Criminal Justice (MOCJ) to retroactively**
4 **accept and expend a grant in the amount of \$200,000 from the State Board of**
5 **Corrections, from funds made available through the Title II Delinquency Prevention and**
6 **Intervention Program (Title II), for the “Read into Your Future” literacy project.**

8 WHEREAS, MOCJ is the lead programmatic and fiscal agency of the City and County
9 of San Francisco in administering the Title II grant, which provides funds for San Francisco to
10 implement an intensive literacy program for youths involved in the juvenile justice system; and

11 WHEREAS, San Francisco applied for and was awarded on December 2, 2003, a Title
12 II grant in the amount of two hundred thousand dollars (\$200,000); and

13 WHEREAS, the Juvenile Probation Department will be responsible for day to day
14 operations of the “Read into Your Future” literacy project; and

15 WHEREAS, pursuant to the grant application, the Mayor’s Office of Criminal Justice will
16 be providing a grant to Urban Services YMCA, which will subcontract with the Lindamood-Bell
17 Learning Processes to provide intensive tutoring services, and

18 WHEREAS, Lindamood-Bell Learning Processes will provide an in-kind match of
19 services worth \$173,895 to supplement the grant; and


20 WHEREAS, MOCJ will be responsible for the fiscal and programmatic reporting to the
21 Board of Corrections; now, therefore be it

22 **RESOLVED**, that the City and County of San Francisco hereby authorizes MOCJ to
23 retroactively accept and expend \$200,000 from the State Board of Corrections to administer
24 the Title II Delinquency Prevention and Intervention Program; and be it

1 FURTHER RESOLVED, that the City and County of San Francisco hereby accepts the
2 in-kind match of services worth \$173,895 provided by Lindamood-Bell Learning Processes.






