RESOLUTION NO. 437-04

1 [Consolidation of BART District Election and BART Bond Election with the Consolidated
2 General Election scheduled for November 2, 2004.]

3 **Resolution consolidating the Bay Area Rapid Transit (BART) District Election and the**
4 **BART Special District Election for Seismic Safety Bonds, to be held in the City and**
5 **County of San Francisco on November 2, 2004, with the Consolidated General Election**
6 **and any special municipal bond elections to be held in the City and County of San**
7 **Francisco on the same date, and providing that the election precincts, voting places**
8 **and officers for the BART elections shall be the same as for the Consolidated General**
9 **Election and any special municipal bond elections.**

10 WHEREAS, A Consolidated General Election is scheduled to be held in the City and
11 County of San Francisco on November 2, 2004 for the purpose of voting on candidates for
12 federal, state and local office and proposed state and local ballot measures to be submitted to
13 the voters; and

14 WHEREAS, The Board of Supervisors may call for one or more special elections to be
15 held in the City and County of San Francisco on November 2, 2004 for the purpose of voting
16 on proposed municipal bond measures, and consolidate any such elections with the
17 Consolidated General Election scheduled for the same date; and

18 WHEREAS, The BART District Board of Directors called a district election to be held in
19 the City and County of San Francisco on November 2, 2004 for the Director's seat in districts
20 7 and 9; and

21 WHEREAS, The BART District Board of Directors adopted Resolution Numbers 4907
22 and 4652 requesting consolidation of the BART district election on November 2, 2004 with the
23 Consolidated General Election scheduled for the same date, and setting fees for candidate
24 statements for the BART Board of Directors ; and

1 WHEREAS, The BART Board of Directors filed Resolutions 4907 and 4652 with the
2 City and County of San Francisco on or before June 29, 2004; and,

3 WHEREAS, The BART District Board of Directors called a special district election for
4 seismic safety bonds in the City and County of San Francisco on November 2, 2004; and

5 WHEREAS, The BART Board of Directors adopted Resolution Numbers 4920 and
6 4921, requesting consolidation of the BART special district bond election on November 2,
7 2004 with the Consolidated General Election scheduled for the same date, and providing for
8 reimbursement of the City and County of San Francisco of certain expenses associated with
9 the special district bond election; and

10 WHEREAS, The BART Board of Directors District filed Resolutions 4920 and 4921 with
11 the City on June 29, 2004; and,

12 WHEREAS, The Board of Supervisors believes that it is in the best interests of the
13 public that these elections be consolidated, as authorized by law; now, therefore, be it

14 RESOLVED, That pursuant to Elections Code section 10400 et seq., the BART
15 elections to be held in the City and County of San Francisco on November 2, 2004 shall be
16 and hereby are consolidated with the Consolidated General Election and any special
17 municipal bond elections scheduled for the same date; and, be it

18 FURTHER RESOLVED, That the voting precincts, polling places, and officers of the
19 BART elections shall, in every case, be the same; that there shall be only one set of election
20 officers in each precinct, to wit, the election officers to be appointed by the Director of
21 Elections for each precinct; that all candidates, ballot measures and bond proposals shall be
22 set forth on the ballots provided for said election; that the elections shall be held in all respects
23 as though there were only one election, and that all returns shall be canvassed by the Director
24 of Elections as provided in the California Elections Code.


