RESOLUTION NO. 440-04

[Supporting AB 2146.]

Resolution urging the California State Legislature to support AB 2146, legislation establishing a pilot program to limit the number of Dungeness crab traps allowed on each commercial fishing vessel and give authority to the Fish and Game Commission to regulate the Dungeness crab industry.

WHEREAS, Dungeness Crab fishing has been a San Francisco tradition since the Gold Rush, however, since the 1970's, California crab fishing has become increasingly dominated by large commercial boats; and,

WHEREAS, San Francisco's Dungeness crab has traditionally been harvested and delivered to Fisherman's Wharf by small and medium sized family owned local boats; and,

WHEREAS, In the past, those crabs were bought, processed and distributed to small, family-owned fish markets, crab stands, and restaurants; and,

WHEREAS, Over the years, there has been a decline in these family owned and small business boats due to their inability to compete with larger boats and processors from the north; and,

WHEREAS, Large crab boats (larger than 50 feet), based North of Mendocino County and in Oregon and Washington State have begun over-fishing the San Francisco Bay; and,

WHEREAS, Though this over crabbing is not creating a resource problem for the crab species (crabbers are required to throw back small crabs and all females to maintain a strong crab population), it is preventing sustainable crabbing throughout the season for the fishermen dependent on these crabs for their livelihood; and,

WHEREAS, In response to these concerns, Assemblyman Mark Leno authored legislation sponsored by the Pacific Coast Federation of Fisherman's Association and

2	others that would create a Dungeness crab trap limit of 250 traps per vessel in all Fish and

4	regulate the Dungeness crab industry; now, therefore be it
5	RESOLVED, That the Board of Supervisors of the City and County of San Francisco
6	supports AB 2146 in its amended form; and, be it
7	FURTHER RESOLVED, That the Board of Supervisors urges members of the
8	California State Legislature to support AB 2146; and, be it
9	FURTHER RESOLVED, That, upon adoption, a copy of this resolution will be
0	forwarded to the office of Assemblymen Mark Leno and Leland Yee.
