[FISCAL EMERGENCY/PROPOSITION J CONTRACT-MAINFRAME SUPPORT]

Resolution concurring with the Mayor's determination of a fiscal emergency and with the Controller's certification that mainframe support can be practically performed by a private contractor at a lower cost than by City and County employees.

WHEREAS, The significant slow down to the national, State and local economies have created a fiscal emergency for the City and County of San Francisco; and,

WHEREAS, This economic slow down has resulted in unexpected revenue shortfalls for the State of California and for the City and County of San Francisco; and,

WHEREAS, Emergency cost saving measures are being enacted by the Federal, State and numerous local governments across the country and throughout California; and,

WHEREAS, The impact of California's projected \$15 billion budget deficit for 2004-2005 upon the City and County of San Francisco is approximately \$60 million dollars, which will result in substantial additional revenue reductions to the City and County budget; and,

WHEREAS, The City and County of San Francisco must reconcile a projected \$299 million budget deficit for 2004-2005 with a Charter obligation to enact a balanced budget each fiscal year; and,

WHEREAS, Section 10.104.15 of the San Francisco Charter allows City Departments to contract for services performed by employees subject to civil service examination when it has been determined by the Office of the Controller that can be practically performed under private contract at a lower cost to the City than similar work performed by City and County employees; and,

WHEREAS, The Department of Telecommunications and Information Services provides mainframe services, including management of projects and staff; installation and

configuration of systems; maintenance; and support operations that can be available through private contract for lower cost; and,

WHEREAS, The Office of the Controller has certified that the requirements of Charter Section 10.104.15 have been satisfied for Fiscal Year 2004-05 and has determined that contracting for the mainframe services provided under this contract is more economical than providing the same services with City and County employees; and,

WHEREAS, The Controller's certification is on file with the Clerk of the Board of Supervisors in File No. <u>040785</u>, which is hereby declared to be a part of this resolution as if set forth fully herein; now, therefore, be it

RESOLVED, That the Board of Supervisors concurs with the Mayor's determination of a fiscal emergency and with the Controller's certification that mainframe operations and services can be practically performed by a private contractor at a lower cost than by City and County employees for Fiscal Year 2004-05.
