WHEREAS, "San Francisco's Earthquake Risk" is a study done for the city Department of Building Inspection by the Applied Technology Council of Redwood City that details the potential impacts of an earthquake on San Francisco's economy and infrastructure and calls for seismic retrofitting of existing buildings in the more vulnerable areas; and,

WHEREAS, The U.S. Geological Survey (USGS) and other scientists conclude that there is a 62% probability that a major earthquake will strike the San Francisco Bay region sometime in the next 30 years; and,

WHEREAS, San Francisco's delicate location within the faulty system of the Bay Area – less than 10 miles from both the San Andreas and Hayward faults – places the City at significant risk of damage if the proper preparations are not taken; and,

WHEREAS, "San Francisco's Earthquake Risk" predicted that a 7.2 magnitude earthquake along the San Andreas Fault is estimated to result in 30,000 displaced households and economic losses of \$13.7 billion citywide; and,

WHEREAS, Among their findings, the Council predicted that a 7.2 magnitude earthquake and post-quake fire would destroy 70 percent of the wooden single-family buildings on the west and south sides of the city -- 20, 857 in all; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby urges the Department of Building Inspection to complete and finalize work on their Community Action Plan for Seismic Safety (CAPSS) Report – a study that will include cost-effective mitigation strategies and economic incentives to help avoid future disasters.
