6 WHEREAS, The Board of Supervisors approved the Agreement with PRWT Services,
7 Inc. with Resolution No. 593-98 on July 31, 1998; and,

8 WHEREAS, The Board of Supervisors approved a two-year extension to the
9 Agreement with PRWT Services, Inc. with Resolution No. 677-02 on September 30, 2002;
10 and,

11 WHEREAS, The Department of Parking and Traffic has improved the quality of service
12 provided to the public, become more efficient and has upgraded its information systems used
13 for processing parking citations through its Agreement with PRWT, Services, Inc.; and,

14 WHEREAS, The Municipal Transportation Agency Board of Directors adopted
15 Resolution 04-103 on July 6, 2004 approving a two-year extension to the Agreement with
16 PRWT Services, Inc. and is on file with the Clerk of the Board of Supervisors in File
17 No. 041026, which is hereby declared to be a part of this resolution as if set forth fully
18 herein; and,

19 WHEREAS, The Department of Parking and Traffic is requesting the Board of
20 Supervisors approve a Fourth Amendment to the Agreement with PRWT Services, Inc. which
21 includes a two-year extension because the contract benefits have exceeded the costs; now,
22 therefore, be it

23 RESOLVED, That Board of Supervisors of the City and County of San Francisco
24 hereby approves the proposed Fourth Amendment to the Agreement with PRWT Services,
25 Inc.; and, be it

1 FURTHER RESOLVED, That Board of Supervisors of the City and County of San
2 Francisco authorizes the Executive Director of the Municipal Transportation Agency to enter
3 into the Fourth Amendment to the Agreement in substantially the form of such Fourth
4 Amendment on file with the Clerk of the Board of Supervisors in File No. 041026, which is
5 hereby declared to be a part of this resolution as if set forth fully herein.
