12 WHEREAS, The City Planning Department has verified that the area is properly
13 zoned; and,

14 WHEREAS, The Police Department recommends that the liquor license
15 application be approved with conditions; now, therefore, be it

16 RESOLVED, That in accordance with Section 23958.4 of the California Business
17 and Professions Code, the Board of Supervisors of the City and County of San
18 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
19 on-sale general public premises license from 60 Sixth Street to 52-60 Sixth Street
20 (District 6) for Angel Cruz for Six Inc., dba Club Six, will serve the public convenience
21 and necessity of the people of the City and County of San Francisco.

22 Conditions: (1) The petitioner shall be responsible for maintaining free of litter
23 the area adjacent to the premises over which they have control; (2) The petitioner shall
24 police the area under their control in an effort to prevent loitering of persons about the
25 premises; (3) No noise shall be audible beyond the area under control of the licensee.


