[Urging the PUC to fund a wave-generation power study at Ocean Beach]

**Resolution urging the PUC to fund the Electricity Production Research Institute (EPRI) to complete a study on Ocean Beach necessary for planned implementation of wave-generated power in San Francisco**

WHEREAS, San Francisco has a world-class tidal power resource and an off-shore wave-generation capability, and

WHEREAS, San Franciscans have voted to support renewable energy projects including wave-generated power, solar power, and tidal power through revenue bonds to be used to finance such projects; and

WHEREAS, Such revenue bonds can not be issued until certain preliminary siting studies are completed and financed, without which implementation of such technologies will never occur; and

WHEREAS, Implementation of new energy generating technologies such as these has never happened without government support and financing; and

~~WHEREAS, The State of California has urged the development of new energy technologies but has failed to make good on its promises to follow through with adequate funding; and~~

WHEREAS, San Francisco is currently being offered a leadership role in conjunction with the City of Oakland, to fund a research project that will pave the way for implementation of wave generated power at Ocean Beach; and

WHEREAS, Such a study, if undertaken at a later date will cost the City of San Francisco more to implement; and

1           WHEREAS, The City of Oakland has agreed to contribute \$10,000 at this time in order  
2 to share data produced from this study for the benefit of their own offshore wave generation  
3 project; therefore be it

5           RESOLVED, That The San Francisco Board of Supervisors urges the PUC to fund EPRI in  
6 the amount of \$30,000 with the City of Oakland (contributing an additional \$10,000) in order  
7 for both parties to make possible EPRI's phase one evaluation of site and technology for  
8 renewable energy wave generation of Ocean Beach, San Francisco.


