9 America Vote Act ("HAVA") to modernize voting equipment and to improve other aspects of
10 the elections process; and


11 WHEREAS, The California Secretary of State received this HAVA money and is in the
12 process of allocating a portion of this money to each county to enhance voter education and
13 pollworker training; and,

14 WHEREAS, The Department of Elections applied for and has been awarded a grant
15 not to exceed \$300,000.00 to educate voters and pollworkers on how to use San Francisco's
16 voting system and on new legal requirements relating to absentee voting and provisional
17 voting; now, therefore, be it


18 RESOLVED, That the Department of Elections is hereby authorized retroactively to
19 accept and expend a grant not to exceed \$300,000.00 from the California Secretary of State
20 to educate voters and pollworkers on how to use San Francisco's voting system and on new
21 legal requirements relating to absentee voting and provisional voting; and, be it


1 FURTHER RESOLVED, That the Director of Elections is authorized to enter into an

3 purposes.




