20 Pastor, worked as a public School teacher, insurance consultant, sales manager, and as an
21 industrial injury prevention consultant; and

22 WHEREAS, Rev. Arthur James Eberhardt Sr. was appointed to the San Francisco
23 Commission on the Aging, and served as President for five years; and

24 WHEREAS, Rev. Arthur James Eberhardt Sr. served on the Board of the Bayview
25 Hunters Point Network for Elders 1995-1996; and
